

Call for Artworks:

Breaking Silences, Demanding Crip Justice: Sex, Sexuality and Disability

Submission Criteria and Eligibility:

We are seeking original artworks in all media forms, including: visual art & photography; poetry, music, or solo performance work; and storytelling. Works must explore the intersecting identities of disability and sexuality. This juried exhibition/show is open to artists 18 years and older. Works submitted will be juried by the conference steering committee. All submissions must be original creations by the artist. With multisensory access in mind, our goal is to create a thought-provoking and accessible experience for attendees. All submissions must include information on how the work must be displayed or performed, and how you will ensure visual, auditory, and/or descriptive access for attendees with different disabilities.

Entry Procedure:

Please complete the Art Show Proposal and Loan Agreement Form and include a digital image, video or description of what you would like to present by **November 23rd, 2016**. Digital image files should be in PDF format. Up to three pieces may be submitted for consideration. Accepted work that differs significantly from the juried image or is in poor condition may be disqualified. You will be notified of your acceptance by **June 2017**.

Drop Off/Pick Up:

If applicable, accepted works may be hand delivered on **Thursday, September 14th, 2017** to the Wright State University Student Union between **4pm-6pm**. All accepted works should be picked up on **Friday, September 29th, 2015** by **1:00pm** in the same location.

Shipping:

Accepted works sent via shipping will be accepted between **Wednesday, September 13th and Tuesday, September 19th, 2017**. Artwork will be shipped back by **September 27th, 2015**. Artists will be responsible for shipping their work to and from the conference. Please use sturdy, reusable packaging and enclose a prepaid shipping label with the artwork.

Liability/Agreement:

Every precaution is taken in handling entries and securing them while they are on display. Physical artwork will be kept in a locked room on the university campus and monitored by conference organizers and campus security while in our possession. Artwork **will not be insured** for this show and while we will take every precaution to protect your artwork, we are not responsible for lost or damaged artwork. The conference coordinators reserve the right to reject work if it violates the conditions set forth in this proposal or is unsafe to display for any reason.
