**Specifications**

Crop adjustments were made to Vinifera and hybrid wine-grape varieties as follows:

For shoots longer than 24" -> leave 2 clusters

For shoots between 12" and 24" -> 1 cluster

For shoots less than 12" -> no clusters

Leaf removal in all varieties on shaded side of row. Shoot positioning for all wine grape varieties. Hedging done as applicable.
