#### TEMPORARY RECRUITMENT BULLETIN

**Position:** Biological Science Technician (Field Assistant)

Location: Hawaii National Park, Hawaii

Work Schedule: Full-time, with the possibility of part-time or intermittent work

Type of Appointment: Temporary, not-to-exceed 180 days within one year from appointment date. Expected duration of this appointment is 90 days, but it may be extended up to 180 days without further competition.

Date Open: May 07, 2019

Date Close: May 20, 2019

Salary: \$18.65 (Step 01) to \$24.25 (Step 10) per hour with applicable COLA adjustments

NOTE: First time hires to the Federal Government are typically hired at the Step 01.

There is one vacancy; however, this announcement may be used to fill additional vacancies if they become available.

This is a temporary excepted service position for which all qualified applicants, with or without Federal status may apply and be considered. Appointment to this position however will not convey permanent status in the Federal service. Appointment will only be for the duration of the position, normally 6-9 months. Temporary employees are covered by the Social Security Retirement system, may accrue annual and sick leave depending on work and are ineligible for life insurance coverage.

Temporary appointees expected to work at least 130 hours per month for at least 90 days will be eligible to enroll in a <u>Federal Employee Health Benefits (FEHB)</u> plan. Individuals eligible under this rule receive the full government contribution to their premiums regardless of work schedule and will also be eligible to participate in the <u>Flexible Spending</u> <u>Accounts</u> and <u>Federal Long Term Care Insurance Program</u>. Temporary appointees are not covered by the Federal Employee Retirement System and are ineligible for Federal life, dental, or vision insurance. Temporary employees are covered by the Social Security Retirement system, annual and sick leave will be accrued if working a full time or part time work schedule.

Duties: Incumbent performs technical work in a field environment in support of professional or technical employees engaged in data collection activities or analysis of biological data collection activities or analysis of biological samples. Particular emphasis will be placed on supporting Hawaiian hoary bat studies on the island of Hawaii. Performs one or more of the following duties:

- Assist crew leaders in the safe capture, banding, sampling and radio tagging of Hawaiian hoary bats.
- Assist in searches for and tracking of free-ranging bats using radio telemetry tracking and visual searches. Searches are often in very dense vegetation and over rugged terrain.
- Assist in data collection at Hawaiian hoary bat roost sites includung collecting vegetation and habitat metrics.
- Assist with video recording and deploying acoustic monitoring stations at bat roost sites.
- Assist in the preparation, decontamination, and organization of field equipment.
- Assist in the collection, downloading and processing of data from automated telemetry tracking stations and acoustic and video monitoring stations.
- Assist in the collection, management and entry of data from the field to database.

- Assist in other aspects of the research study as needed.
- Operate a government motor vehicle.

Note: You will be required to operate a government-owned or leased vehicle in the performance of your official duties. Applicants for this position must meet the following requirements: (1) possess a valid state driver's license, and (2) possess a safe driving record. If selected, you will be required to provide proof of a valid state driver's license and a current copy of your complete driving record.

**Other Information:** A background investigation will be required for this position. Continued employment will be subject to the successful completion of a background security investigation and favorable adjudication. Failure to successfully meet these requirements will be grounds for termination.

**Travel (if required):** Occasional travel to the island of Oahu or Kauai may be required up to 5 days per month.

Physical Demands: Field work will involve bending, walking and hiking over rough and uneven terrain. Field work involves exposure to conditions ranging from hot and dry to cold and wet. Work often involves driving and conducting field research activities at night. The incumbent may be required to lift and carry equipment weighing up to 50 lbs. Taking and passing a pre-employment medical examination at Federal expense is required due to the physical demands of this job.

**Qualifications:** 1 year, 9 months of field experience or 4 years sub-professional experience or 4 years college study (equivalent 120 semester hours/180 quarter hours) plus 3 months of lab or field work experience.

For all appointments: Education completed in colleges or universities outside the United States may be used to meet the qualification requirements. You must provide acceptable documentation that the foreign education is comparable to that received in an accredited educational institution in the United States. **Basis of Evaluation:** Applicants will receive a basic eligible or ineligible rating based upon the qualification requirements. First preference in referral will be given to eligible

applicants with 10-point veteran's preference who have compensable service connected disability of 10 percent or more. All other qualified applicants entitled to veteran's preference will be given preference over qualified applicants not entitled to veteran's preference.

All applicants must be United States Citizens. Under regulations contained in the Immigration Reform and Control Act of 1986, employment in this position is limited to those persons who are authorized to work in the United States. Verification of employment eligibility will be required at the time of appointment.

As a condition of employment, all new employees reporting for duty with the Department of the Interior will be paid through direct deposits to a financial institution of their choice.

Applicants selected for federal employment will be required to complete a Declaration of Federal Employment, OF-306, prior to being appointed to determine their suitability for federal employment and to authorize a background investigation. Failure to answer all questions truthfully and completely or providing false statements on the application may be grounds for not hiring the applicant or for firing after he/she begins work. Also, he/she may be punished by fine or imprisonment (U.S. code, Title 18, section 1001).

Prior to or at the time of the appointment, male applicants born after December 31, 1959 will have to certify that they have registered with the selective service system in order to be appointed to a position with the United States Geological Survey, unless legally qualified for an exception.

Employees of the U.S. Geological Survey are subject to the provisions of Title 43, U.S. code, Section 31 (a) and may not according to this legislation and related regulations: (A) have any personal or private interest, direct or indirect, in lands or mineral wealth of such lands or a region under survey and whose title is in the U.S.; (B) Execute surveys or examination for private parties or corporations; or (C) have personal or private interest, direct in any private mining or mineral enterprise doing business in the U.S. except where specifically authorized by the director of the U.S. Geological Survey.

**Other Information:** Travel, transportation, and relocation expenses will not be paid by the Federal Government. Any travel, transportation and relocation expenses associated with

reporting for duty in this position will be the responsibility of the selected employee.

**Telework:** The U.S. Geological Survey has determined that the duties of this position are suitable for telework only during an emergency or natural disaster. For additional information on our internal telework policy, please reference the Department of the Interior Telework Handbook

How to Apply: Carefully read all information and instructions. It is the responsibility of the applicant to insure the application is completed. The personnel office will not be responsible for soliciting additional information from applicants or from official personnel records, but will consider individuals based on their application as submitted.

Submit resume and college transcript or a list of college courses, specify title of course work, completion date, semester or quarter hours earned by course title, and grade earned.

If claiming 5 point veteran's preference, a DD-214 showing character of discharge is required.

If claiming 10 point veteran's preference, a SF-15 with proof of claim is required.

If you are claiming veterans' preference you must submit a copy of your DD-214, Certificate of Release or Discharge from Active Duty, by the closing date of this announcement. If you are currently on active military duty, you must provide documentation (e.g., campaign document, award citation, etc.), that verifies entitlement to veterans preference and that your character of military service is honorable. If you are claiming 10-point veterans' preference, in addition to the DD-214, you must submit documentation that supports your claim (e.g., an official statement from the Department of Veterans Affairs or from a branch of the Armed Forces certifying the existence of a service-connected disability; or receipt of a Purple Heart).
